

**JOINT DECLARATION OF INTENT  
BETWEEN  
THE FEDERAL MINISTRY OF HEALTH OF THE FEDERAL REPUBLIC OF  
GERMANY  
AND  
THE MINISTRY OF HEALTH OF THE REPUBLIC OF INDONESIA  
ON HEALTH COOPERATION**

The Federal Ministry of Health of the Federal Republic of Germany and the Ministry of Health of the Republic of Indonesia (hereinafter singularly referred to as "the Side" and collectively referred to as "the Sides"),

Referring to the Jakarta Declaration (Indonesia-Germany Joint Declaration for a Comprehensive Partnership: Shaping Globalisation and Sharing Responsibility) signed on 10 July 2012,

Strive through this Joint Declaration of Intent (hereinafter referred to as "JD") to strengthen the friendly relationship between the Sides, and to promote health cooperation between the two Sides on the basis of mutual benefit and mutual respect.

The Sides affirm the need to carry out cooperation in the areas of mutual interest in the health sector. Therefore, the Sides

**HAVE COME TO THE FOLLOWING UNDERSTANDING:**

- I. With the purpose of further promoting beneficial and intensified cooperation, the Sides intend to exchange experience and cooperate in the following fields:
  - a) health services;
  - b) disease prevention and control;

- c) public health;
- d) pharmaceutical and medical devices; and
- e) development of human resources in the health sector.

II. The implementation of cooperation specified above will be carried out through the following methods:

- a) exchange of information, expertise and experiences regarding organisation, structure and reforms in the field of health;
- b) exchange of experts, delegations and health related personnel in order to realize short term postgraduate education and training in medical specialities, improvement of professional skills and consultancy;
- c) support for and involvement of both Sides in meetings, seminars and conferences in different health disciplines for both countries' researchers, health professionals and administrators;
- d) support for direct contacts among related foundations, institutions and organisations; and
- e) other methods of cooperation to be mutually decided upon by the Sides.

III. The Sides may conclude separate arrangements that set out specific details of joint cooperative projects and/or programs for carrying out the cooperation jointly decided upon under this JD.

IV. Subject to the prevailing laws and regulations of their respective countries, each Side aims to respect the Intellectual Property Rights of the other Side in carrying out cooperation activities under this JD. Any outcome, data and information resulting from activities conducted under this JD is intended to be jointly owned by the Sides, and the Sides strive to use such property only for non-commercial purposes, free of royalty.

V. The Sides intend to settle any disputes between the Sides arising out of the interpretation or implementation of this JD amicably by consultations and/or negotiations between the Sides.



- VI. This JD can be amended at any time through mutual written consent of the Sides.
- VII. For the purpose of monitoring and ensuring the follow up of this JD, the Sides may set up a Joint Working Group (JWG) to discuss and decide the cooperation activities. JWG will meet up on date and place to be mutually decided or virtually.
- VIII. This JD will come into effect on the date of last signature. This JD can be terminated by either of the Sides at any time with prior written notice to the other Side, if ever possible no later than six (6) months prior to the date of desired termination. The termination of the JD will not affect the completion of on-going cooperation conducted under this JD and/or arrangement made under this JD, unless otherwise specified by the Sides.
- IX. This JD is not designed to create legal rights or obligations under international law for the Sides.

**SIGNED** in duplicate in Berlin on 25.02. 2021 and in Jakarta on .....2021, in Indonesian, German, and English languages, all texts being equally valid. In case of divergence on the interpretation of this JD, the English text will prevail.
